TOPICS AND GOALS

The first S7 Summit serves as the premier platform for open, voluntary, and consensus-based standards to engage with the G7. It encompasses the National Standards Organisations of the G7 countries and issues recommendations on overarching themes impacting industry, SMEs, academia, research, consumers, trade unions, the third sector, public administrations and future generations.

The significant declarations and commitments from the G7 Digital and Tech Ministers in 2023, along with those from the G7 Hiroshima Leaders underscore the imperative of upholding democratic principles in technological advancement. They advocate for safe and trustworthy AI through international codes of conduct and endorse collaboration on policy matters and technical standards.

They reaffirm their commitment to inclusive stakeholder engagement in standards development, particularly focusing on support for SMEs and startups, while also pledging to enhance collaboration on future networks, promote clean energy technologies, and prioritize resilient global supply chains with high environmental, social, and governance standards.

These priorities were discussed and further advanced during the G7 Ministerial Meeting on Industry, Technology and Digital held in mid-March in Verona and Trento.

Standards serve as a cornerstone in addressing multifaceted issues within cohesive G7 nations, not only guiding trade and commerce but also inspiring worldwide endeavours to preserve the environment for upcoming generations, ensuring quality, safety, fair competition, and consumer trust in global markets.

Under the Italian G7 Presidency, Standards Organisations will address stakeholders' concerns related to political agendas and provide responses rooted in existing knowledge and ongoing technical standards development. Additionally, they will offer insights into future technical standardisation work across emerging fields such as enabling technologies for industry, critical raw material sustainability, quantum technologies, and artificial intelligence.
